### Section 4. First aid measures

#### **Description of necessary first aid measures**

Eye contact

Skin contact

Ingestion

Remove victim to fresh air and keep at rest in a position comfortable for breathing. If material has been swallowed and the exposed person is conscious, give small quantities of water to drink. #### Methods and material for containment and cleaning up

Small spill

#### **Protective measures**

#### Appropriate engineering controls
