Description of necessary first aid measures

Personal precautions, protective equipment and emergency procedures

For non-emergency personnel

Methods and material for containment and cleaning up

Small spill

Precautions for safe handling

Protective measures

Avoid exposure - obtain special instructions before use. Do not handle until all safety precautions have been read and understood. Do not get in eyes or on skin or clothing. Conditions for safe storage, : Store in accordance with local regulations. Store in a segregated and approved area.
