	<b>NEWBUILDING</b> Where necessary, remove weld spatter and smooth weld seams and sharp edges. Welds and damaged areas should be blast cleaned to Sa2 <sup>1</sup> / <sub>2</sub> (ISO 8501-1:2007). Intact shop primer should be prepared by sweep blasting to International Paint standard AS3 or by power tooling to Pt3 (JSRA SSPC:1984). #### MAJOR REFURBISHMENT

Abrasive blast clean to Sa2<sup>1</sup>/<sub>2</sub> (ISO 8501-1:2007). If oxidation has occurred between blasting and application of Interline 925, the surface should be reblasted to the specified visual standard.

Surface defects revealed by the blast cleaning process, should be ground, filled, or treated in the appropriate manner.

LIMITATIONS

At ambient temperatures below 25°C paint lines must be lagged. In-line heaters should not be used unless absolutely necessary. Consult International Paint for detailed instructions.

This product will not cure adequately below 10°C. For maximum performance the curing temperature should be kept below 35°C. Particular care should be taken to avoid exceeding this in localised areas when artificial heating is introduced.

The climatic conditions within the tank must be controlled to maintain a maximum relative humidity of 50% at temperatures between 10-15°C, and a maximum relative humidity of 60% at temperatures of 16°C and above. The drying times and overcoating intervals may alter due to various on-site factors such as tank configuration and ventilation rates. Maximum overcoating intervals may need to be reduced when application takes place in conditions of poor ventilation. Consult International Paint.
