### SURFACE PREPARATIONS

All surfaces to be coated should be clean, dry and free from contamination. High pressure fresh water wash or fresh water wash, as appropriate, and remove all oil or grease, soluble

High pressure fresh water wash or fresh water wash, as appropriate, and remove all oil or grease, soluble contaminants and other foreign matter in accordance with SSPC-SP1 solvent cleaning.

#### **NEWBUILDING**

Dependent on yard procedures. Consult International Paint.

Use in accordance with the standard Worldwide Marine Specifications.

### **MAJOR REFURBISHMENT**

Interspeed 5640 should always be applied over a recommended primer coating scheme. The primer surface should be dry and free from all contamination, and Interspeed 5640 must be applied within the overcoating intervals specified (consult the relevant product data sheet).

Areas of breakdown, damage etc. should be prepared to the specified standard (eg. Sa2½ (ISO 8501-1:2007)) and primed prior to the application of Interspeed 5640.

#### REPAIR

Clean the entire area with close high pressure fresh water washing using a fan-jet lance held close to the surface (3,000 p.s.i., 211 kg/cm²) as soon as the vessel enters dock and before it dries out.

Consult International Paint for alternative methods of surface preparation.

Repair corroded areas with the recommended anticorrosive primer system and apply Interspeed 5640 within the overcoating interval specified for the primer (consult relevant primer data sheets).

Consult your International Paint representative for specific recommendations.
