### Section 4. First aid measures

#### **Description of necessary first aid measures**

**Eve contact** 

: Get medical attention immediately. Call a poison center or physician. Immediately flush eyes with plenty of water, occasionally lifting the upper and lower eyelids. Check for and remove any contact lenses. Continue to rinse for at least 10 minutes. Chemical burns must be treated promptly by a physician.

Inhalation

### Section 6. Accidental release measures

#### Large spill

: Stop leak if without risk. Move containers from spill area. Use spark-proof tools and explosion-proof equipment. Approach the release from upwind. Prevent entry into sewers, water courses, basements or confined areas. Wash spillages into an effluent treatment plant or proceed as follows. ### Section 7. Handling and storage

#### Precautions for safe handling

#### **Protective measures**

# Appropriate engineering controls
