Description of necessary first aid measures

Immediately flush eyes with plenty of water, occasionally lifting the upper and lower eyelids. Check for and remove any contact lenses. Continue to rinse for at least 10 minutes. Get medical attention following exposure or if feeling unwell.

Precautions for safe handling

Put on appropriate personal protective equipment (see Section 8). Avoid exposure - : Protective measures obtain special instructions before use. Avoid exposure during pregnancy.
