4.2. Most important symptoms and effects, both acute and delayed

# 5.2. Special hazards arising from the substance or mixture

#### 6. Accidental release measures

### 6.1. Personal precautions, protective equipment and emergency procedures

ELIMINATE ALL IGNITION SOURCES (no smoking, flares, sparks or flames in immediate area). Use only non-sparking equipment to handle spilled material and absorbent. ### 6.3. Methods and material for containment and cleaning up
