## Description of necessary first aid measures

Eye contact

### Ingestion

### **Extinguishing media**

Specific hazards arising from the chemical

For non-emergency personnel

Do not touch or walk through spilt material. Shut off all ignition sources. No flares, smoking or flames in hazard area. Do not breathe vapour or mist. Provide adequate ventilation. Wear appropriate respirator when ventilation is inadequate. Put on appropriate personal protective equipment.

## Large spill

: Stop leak if without risk. Move containers from spill area. Use spark-proof tools and explosion-proof equipment. Approach the release from upwind. Prevent entry into sewers, water courses, basements or confined areas. Wash spillages into an effluent treatment plant or proceed as follows. ### Precautions for safe handling

#### Protective measures

Appropriate engineering controls
