

Epoxy Novolac Phenolic Tank Coating

PRODUCT DESCRIPTION A two pack, novolac phenolic epoxy cargo tank coating for application down to 5°C.

INTENDED USES Suitable for the carriage of an extensive range of aggressive cargoes including solvents and chemicals, clean and dirty petroleum products, vegetable and animal oils.
For use at Newbuilding or Maintenance & Repair.

SYSTEMS AND COMPATIBILITY

When using in cargo or grey water tanks, consult the Interline 994LT Cargo Tank or Grey Water Tanks Application Guidelines.

Consult your International Paint representative for the system best suited for the surfaces to be protected.

SURFACE PREPARATIONS

Use in accordance with the standard Worldwide Marine Specifications.

All surfaces to be coated should be clean, dry and free from contamination.

High pressure fresh water wash or fresh water wash, as appropriate, and remove all oil or grease, soluble contaminants and other foreign matter in accordance with SSPC-SP1 solvent cleaning.

NEWBUILDING/MAJOR REFURBISHMENT

Where necessary, remove weld spatter and smooth weld seams and sharp edges.

Abrasive blast clean to Sa2½ (ISO 8501-1:2007). If oxidation has occurred between blasting and application of Interline 994LT, the surface should be reblasted to the specified visual standard.

Surface defects revealed by the blast cleaning process, should be ground, welded, or treated in the appropriate manner.

REPAIR

Consult International Paint.

Consult your International Paint representative for specific recommendations.

NOTE

For use in Marine situations in North America, the following surface preparation standards can be used: SSPC-SP10 in place of Sa2½ (ISO 8501-1:2007)

APPLICATION

Mixing	Material is supplied in 2 containers as a unit. Always mix a complete unit in the proportions supplied. (1) Agitate Base (Part A) with a power agitator. (2) Combine entire contents of Curing Agent (Part B) with Base (Part A) and mix thoroughly with power agitator.
Thinner	Not recommended. Use International GTA007 only in exceptional circumstances. DO NOT thin more than allowed by local environmental legislation.
Airless Spray	Recommended Tip Range 0.38-0.58 mm (15-23 thou) Total output fluid pressure at spray tip not less than 176 kg/cm ² (2500 p.s.i.)
Conventional Spray	Application by conventional spray is not recommended.
Brush	Application by brush is recommended for small areas only. Multiple coats may be required to achieve specified film thickness.
Roller	Application by roller is recommended for small areas only. Multiple coats may be required to achieve specified film thickness.
Cleaner	International GTA415/GTA822
Work Stoppages and Cleanup	Do not allow material to remain in hoses, gun or spray equipment. Thoroughly flush all equipment with International GTA415/GTA822. Once units of paint have been mixed they should not be resealed and it is advised that after prolonged stoppages work recommences with freshly mixed units. Clean all equipment immediately after use with International GTA415/GTA822. It is good working practice to periodically flush out spray equipment during the course of the working day. Frequency of cleaning will depend upon amount sprayed, temperature and elapsed time, including any delays. Do not exceed pot life limitations. All surplus materials and empty containers should be disposed of in accordance with appropriate regional regulations/legislation.
Welding	In the event welding or flame cutting is performed on metal coated with this product, dust and fumes will be emitted which will require the use of appropriate personal protective equipment and adequate local exhaust ventilation. In North America do so in accordance with instruction in ANSI/ASC Z49.1 "Safety in Welding and Cutting."

SAFETY

All work involving the application and use of this product should be performed in compliance with all relevant national Health, Safety & Environmental standards and regulations.

Prior to use, obtain, consult and follow the Material Safety Data Sheet for this product concerning health and safety information. LIMITATIONS

Film Thickness

The minimum dft for the system is 240 microns.
The maximum dft for the system is 450 microns.

In way of areas of tanks that are difficult to paint due to their configuration, e.g heavily stiffened tanks, and where a degree of overthickness is unavoidable, a maximum of 600 microns dft is acceptable.

This product will not cure adequately below 5°C. At no time during the application, and up to the first 48 hours after application of the final coat must the steel temperature fall below 5°C and the relative humidity exceed 80%. International Paint should be consulted to confirm that the tank coating is suitable for the range of cargoes to be carried. For carriage of certain cargoes, a mandatory heated post-cure is required - consult the International Paint Cargo Resistance Guide.

The drying times and overcoating intervals may alter due to various on-site factors such as tank configuration, ventilation rates, etc. Consult the detailed application procedure for the time interval required between coating completion and cargo loading.

Overcoating information is given for guidance only and is subject to regional variation depending upon local climate and environmental conditions. Consult your local International Paint representative for specific recommendations.

Apply in good weather. Temperature of the surface to be coated must be at least 3°C above the dew point and a minimum of 5°C. The minimum temperature of 5°C must be maintained throughout the application (including between coats) and for a minimum period of 48 hours after application of the final coat of the system. Base and curing agent must be heated to a minimum of 15°C before and during application. In winter months, paint should be stored above 15°C for a minimum of 48 hours to achieve the required minimum paint temperature.

If the temperature exceeds 25°C cooling will be required to bring base and curing agent temperatures within 15-25°C prior to application. Unmixed material (in closed containers) should be maintained in protected storage in accordance with information given in the STORAGE Section of this data sheet
