Section 4. First aid measures

Description of necessary first aid measures

Eye contact

Methods and material for containment and cleaning up

Small spill

Section 7. Handling and storage

Precautions for safe handling

Protective measures

Put on appropriate personal protective equipment (see Section 8). Persons with a history of skin sensitisation problems or asthma, allergies or chronic or recurrent respiratory disease should not be employed in any process in which this product is used. Do not get in eyes or on skin or clothing. Do not breathe vapour or mist. Do not ingest. Avoid release to the environment. Use only with adequate ventilation. Wear appropriate respirator when ventilation is inadequate. Do not enter storage areas and confined spaces unless adequately ventilated. Section 8. Exposure controls/personal protection

Appropriate engineering controls

: Use only with adequate ventilation.
