## Section 5. Firefighting measures

#### Specific hazards arising from the chemical

: Flammable liquid and vapour. In a fire or if heated, a pressure increase will occur and the container may burst, with the risk of a subsequent explosion. Runoff to sewer may create fire or explosion hazard. This material is harmful to aquatic life with long lasting effects. #### **Environmental precautions**

#### Methods and material for containment and cleaning up

## Section 7. Handling and storage

#### Precautions for safe handling

#### Protective measures

: Put on appropriate personal protective equipment (see Section 8). Persons with a history of skin sensitization problems should not be employed in any process in which this product is used. ## Appropriate engineering controls
