## Section 4. First-aid measures

### **Description of necessary first aid measures**

Eye contact

Skin contact

Ingestion

# Section 5. Fire-fighting measures

### Specific hazards arising from the chemical

: Flammable liquid and vapour. In a fire or if heated, a pressure increase will occur and the container may burst, with the risk of a subsequent explosion. Runoff to sewer may create fire or explosion hazard. This material is very toxic to aquatic life with long lasting effects. ### For non-emergency personnel

Do not touch or walk through spilt material. Shut off all ignition sources. No flares, smoking or flames in hazard area. Do not breathe vapour or mist. Provide adequate ventilation. Wear appropriate respirator when ventilation is inadequate. Put on appropriate personal protective equipment.

#### **Environmental precautions**

### Methods and materials for containment and cleaning up

#### Small spill

# Section 7. Handling and storage

#### Precautions for safe handling

#### **Protective measures**
