## Section 4. First aid measures

### Description of necessary first aid measures

Eye contact

#### **Extinguishing media**

Specific hazards arising from the chemical

## Section 6. Accidental release measures

#### Large spill

: Stop leak if without risk. Move containers from spill area. Use spark-proof tools and explosion-proof equipment. Approach the release from upwind. Prevent entry into sewers, water courses, basements or confined areas. Wash spillages into an effluent treatment plant or proceed as follows. #### Precautions for safe handling

Appropriate engineering controls
