Description of necessary first aid measures

Eve contact

Personal precautions, protective equipment and emergency procedures

Methods and material for containment and cleaning up

Small spill

Section 7. Handling and storage

Precautions for safe handling

Protective measures

: Put on appropriate personal protective equipment (see Section 8). Persons with a history of skin sensitisation problems or asthma, allergies or chronic or recurrent respiratory disease should not be employed in any process in which this product is used. Section 7. Handling and storage

Advice on general occupational hygiene
