SECTION 4: First aid measures

4.1. Description of first aid measures

General

SECTION 5: Fire-fighting measures

5.1. Extinguishing media

Recommended extinguishing media; alcohol resistant foam, CO². powder, water spray.

SECTION 6: Accidental release measures

6.1. Personal precautions, protective equipment and emergency procedures

Remove sources of ignition, do not turn lights or unprotected electrical equipment on or off. In case of a major spill or spillage in a confined space evacuate the area and check that solvent vapour levels are below the Lower Explosive Limit before re-entering.

6.2. Environmental precautions

6.3. Methods and material for containment and cleaning up

SECTION 7: Handling and storage

7.1. Precautions for safe handling

Handling

This coating contains solvents. Solvent vapours are heavier than air and may spread along floors. Vapours may form explosive mixtures with air. Areas of storage, preparation and application should be ventilated to prevent the creation of flammable or explosive concentrations of vapour in air and avoid vapour concentrations higher than the occupational exposure limits.

In Storage

Handle containers carefully to prevent damage and spillage.

Naked flames and smoking should not be permitted in storage areas. It is recommended that fork lift trucks and electrical equipment are protected to the appropriate standard.

7.2. Conditions for safe storage, including any incompatibilities

Keep away from the following materials: oxidising agents, strong alkalis, strong acids.

Prevent unauthorised access.

Materials such as cleaning rags, paper wipes and protective clothing, which are contaminated with the product, may spontaneously self-ignite some hours later. To avoid the risk of fires, all contaminated materials should be placed in a closed metal container soaked with water. Contaminated materials should be removed from the workplace at the end of each working day and be stored outside.

8.2. Exposure controls

Provide adequate ventilation. Where reasonably practicable this should be achieved by the use of local exhaust ventilation and good general extraction. If these are not sufficient to maintain concentrations of particulates and any vapour below occupational exposure limits suitable respiratory protection must be worn.

Eye/face protection
